After online submission, the candidate must submit hard copy of application along with Acknowledgement slip and all **required documents** either through registered post or at the Drop Box at the District Child Protection Unit, Office of the District Magistrate, PO.- Midnapore, Dist.- Paschim Medinipur, Pin.- 721101, West Bengal.

Documents required:

- Self-attested copies of Date of Birth, Caste Certificate (where applicable), Address Proof & certificate & mark sheet of MP or equivalent examination, HS, Degree & Master Degree as per post criteria.
- Self-Attested Basic Computer course certificate (where applicable).

- iii) Experience Certificates must consist of employers & employee's name, name of the post, date of joining & date of leaving otherwise experience certificate will be treated as invalid.
- iv) Candidature will be cancelled if candidate fails to submit any requisite document(s).

Examination procedure: Written test, Computer test and Viva-voce/Personality test.

Details of examination Syllabus:

- **For Sl. No. 1, 2 and 3:** Written test (Arithmetic – 20 marks, G.K. – 15 marks, English – 15 marks, Bengali – 10 marks, Child Protection– 20 marks) of 80 marks (multiple choice), Computer test (Ms-Office, Internet, e-mail) 10 marks and Viva-voce 10 marks, will be held.
- **For Sl. No. 4:** Written test (Arithmetic – 20 marks, G.K. – 20 marks, English – 15 marks, Bengali – 15 marks, Child Protection– 20 marks) of 90 marks (multiple choice) and Viva-voce of 10 marks will be held.
- **For Sl. No. 5:** Written test (Arithmetic – 20 marks, G.K. – 20 marks, English – 15 marks, Bengali – 15 marks, Child Health– 20 marks) of **90 marks** (multiple choice) and **Viva-voce 10 marks** will be held.
- **For Sl. No. 6:** Written test (Arithmetic – 20 marks, G.K. – 15 marks, English – 15 marks, Bengali – 10 marks, Accountancy– 20 marks)) of **80 marks** (multiple choice), **Computer test** (Ms-Office, Internet, e-mail) **10 marks** and **Viva-voce 10 marks** will be held.
- **For Sl. No. 7, 8 & 9:** Viva-voce test of **10 marks** will be held.


